This Notice may be cited as the Public Service (Delegation of Functions and Powers of the Secretariat to Conduct Recruitment Process) (Amendment) Notice, 2021, and shall be read as one with the Public Service (Delegation of Functions and Powers of the Secretariat to Conduct Recruitment Process) Notice, 2019.

Amendment of
enabling

2. The principal Notice is amended by deleting the enabling provision appearing immediately below the title “NOTICE” and substituting for it the following “*Made under section 29A(1)*”

Amendment of
paragraph 2

3. The principal Notice is amended in paragraph 2, in the definition of the term “Rules” by deleting the words “Rules of Operation of the Public Service recruitment Secretariat, 2019” and substituting for them the words “Public Service Recruitment Secretariat Rules of Operation, 2021.

Amendment of
paragraph 4

4. The principal Notice is amended in paragraph 4-
(a) In sub-paragraph (1), by deleting the words “Rules of Operation of the Public Service Recruitment Secretariat, 2019” and

- substituting for them the words “Public Service Recruitment Secretariat Rules of Operation, 2021;
- (b) by adding in sub-paragraph 1(d) the words “and conduct of” between the word “for” and “interview”;
 - (c) deleting sub- paragraph 1(f) and (h);
 - (d) by renumbering sub-paragraphs 1(g) and (i) as sub-paragraph (f) and (g); and
 - (e) by adding immediately after sub-paragraph (4) the following:

“The Council or the Higher Learning Public Institution shall keep for six months, a database of applicants who passed the interview and such database shall be used to fill vacancy upon approval of Secretary.”.

5. The principal Notice is amended in paragraph 6 by deleting the words “paragraph 4(1)(h)” and substituting for them the words “paragraph 4(5)”.

6. The Principal Notice is amended in Part A of the Schedule by deleting item 15.
